SHCA AFTER SCHOOL PROGRAM - SHCA (K through 6th)

Dear Parents and Guardians,

Sacred Heart Catholic Academy offers an After School Program for SHCA students in grades K through 6th. Participation in the program for students in grades 7th and 8th are negotiable. Please contact the school for further information. The SHCA After School Program runs Monday through Friday from dismissal until 6:00 p.m. and includes snack time (students are to bring their own snacks), free play time (gym or on occasion, in the school yard), crafts, and movies, all under the supervision of SHCA faculty.

Participation in the After School Program is on a monthly basis with the option to choose from a 5-day or 3-day program. If choosing the 3-day program, you must select which set of three days at the beginning of each month. Please note, pre registration to the program is required. *Payments are due at the beginning of each month.*

The cost of the program is a follows:

Registration	\$25.00 Due at time of registration with the attached form completed.
5-Day Program	\$200.00 per month (one child) \$300.00 per month (two children) \$400.00 per month (three children)
3-Day Program (requires specific days)	\$149.00 per month (one child) \$225.00 per month (two children) \$305.00 per month (three children)
1 Day Rate	\$25.00 per day / per child
Pick up by 4:00 p.m.	\$10.00 per child This rate will be applied if your child is picked between 3:15- 4:00 p.m.
Late Fee	\$10.00 per day / per child / every 15 minutes after 6:00 p.m.

As noted above, families using the program on a monthly basis, payments are due at the beginning of each month. Families using the program on a day to day basis will be billed at the end of the month. All

students are required to have all necessary homework materials as they will not be allowed back in the classrooms after dismissal.

Families who would like the program available to them in the event of an emergency will also be required to complete and return the attached Permission Form along with the \$25 registration fee.

The designated door for After School pick up is the 78th Avenue entrance.

All After School Permission/Information Forms and registration fees are to be returned to the school office before the child / children can use the program.
